RECEIVER'S NOTICE OF SECOND INTERIM DISTRIBUTION

Pursuant to Section 3.05 of the Plan of Distribution approved by the Receivership Court, and for the reasons described in his Fifteenth Interim Report, the Receiver gives notice of his intention to proceed with a second interim distribution totaling \$449,941.44 to those Claimants with Approved Claims under the Plan. This distribution will increase the net recovery of those Claimants with Approved Claims to at least 41.63 percent of their total losses. This follows the

first interim distribution of \$1,677,075.56 under the Plan, resulting in a net recovery of 34.58 percent of the total losses of Claimants with Approved Claims.

The Receiver will post a copy of this Notice and an updated second claims spreadsheet (a copy of which is attached as “Exhibit A”) on his firm’s website. All Claimants were previously notified of their claim number, which is the same number listed on both the first and second claims spreadsheet.

Claimants with new addresses are advised to promptly update the Receiver’s office with this information. In preparation for this second interim distribution, the Receiver’s staff has also mailed a notice to all Claimants asking them to verify their addresses (several of which were returned by the USPS indicating a change of address).
